Conference on "Regional transformation processes in the Western Balkan countries".

The Conference will take place from 24-25 February, 2011 in the Great Hall of the Faculty of Business and Economics of University of Pécs.

Participation at the Conference is free of charge, however, registration is required.

The Conference is organised in the framework of the project titled "The socialisation of regional science", whose beneficiary is the Centre for Regional Studies of Hungarian Academy of Sciences.

The Conference is supported by the European Commission, and co-financed by the European Social Fund and the Ministry of National Development.

Objectives

The Conference analyses the transformation of the spatial structure of the countries of the Western Balkans as well as the factors contributing to it. A notable feature of recent decades has been an increase in spatial disparities, and, clearly, a detailed study of these disparities is invariably needed before the implementation of modern spatial policy.

The earlier (tenfold) differences in income between regions in the former Yugoslavia continue to grow, but, more favourably, in addition to the relatively peaceful political conditions, other key factors in the development of the Balkans may be the strengthening of cohesion and the effective implementation of structural policy.

The Conference organised jointly by the Centre for Regional Studies of Hungarian Academy of Sciences, the Hungarian Regional Science Association and the Faculty of Economics and Business of University of Pécs, will be held at the University of Pécs.

The objectives of the Conference will be to:

- give an updated analysis of the regional differences of Balkan countries,
- exchange experience on reasons of strengthening inequalities,
- summarize political and institutional consequences of change of regimes in the Western Balkans,
- outline the development perspectives for the regions,
- identify future research topics for scientific co-operation.

Presentations will build upon results of the research project undertaken by the Centre for Regional Studies of Hungarian Academy of Sciences and OECD LEED Trento Centre for Local Development, Employment and Labour Markets.

The conference aims to foster opportunities for discussion and dialogue among policy makers, researchers, students, tertiary education practitioners, professional associations, representatives of academic staff and other stakeholders.

Three plenary sessions, including one for keynote speakers, will be organised. In this way, participants will be able to follow experiences presented in the Conference. The languages of the Conference are Hungarian and English, interpretation into Serb will be provided.
